HIGHLIGHTS FROM THE DECEMBER 2020 BOARD REORGANIZATION MEETING

There was a presentation of the 2019-20 audit report by the Auditors, Myers, Patsy & Associates.

Superintendent Report: Dr. Johns thanked Mrs. Robinson, Mr. Rajakovic and Mr. O'Keefe for their roles as Officers. She provided an update on a collaboration project with AHN. Dr. Johns also provided an update with the situation with Covid, and spoke about working to improve on the hybrid model.

The Board approved the following items at their December 7, 2020 Board meeting:

- The Northgate Board of School Directors, at their Reorganization meeting, elected Mr. Michael Rajakovic as President, Mr. Daniel O'Keefe as Vice President, and Mrs. Amy Joy Robinson as Treasurer.
- The Board also appointed the law firm of Andrews and Price, as represented by Patricia Andrews, to serve as the School District Solicitor.
- The Public meeting dates, times and location for 2021 were approved as shown on the attached.
- The Board identified <u>The Citizen</u>, Citizen Way, Bellevue, PA 15202, and the <u>Pittsburgh Post-Gazette</u>, 2201 Sweeney Dr., Clinton, PA 15026, as the official school newspapers, either of which may be used for legal advertisements.
- The Board appointed Mr. Daniel O'Keefe and Mr. John Gratner as representatives to the A.W. Beattie Career Center Committee. Also, any interested Board Member may serve and act on behalf of Northgate School District during the absence of appointed representatives.
- Accepted the bid and alternates as listed for the replacement of the interior exit signs at Avalon Elementary School from A-1 Electric, Inc. for their Base Bid price of \$50,200.00 and Alternate E-1 Substitute Exits Signs in the credit amount of (\$9,140.00) and Alternate E-2 to add circuits to an emergency generator source in the amount of \$3,100.00 for a total revised cost of \$44,160.00.
- Approved a continuation of the District's water treatment contract with Chemway for an additional year at a cost of \$6,573.

- Approved an Affiliation Agreement for Internship/Practicum, Pre-clinical and Student Teaching between LaRoche University and Northgate School District.
- Approved a new contract between the Northgate School District and Dr. Caroline Johns for a five (5) year term, commencing July 1, 2021 at a starting salary of \$164,250.
