HIGHLIGHTS FROM FEBRUARY 2021 BOARD MEETINGS

Anna Jean Patalano, Student Council Representative, provided a Student Council update. She spoke about Light Up Hope, which will benefit a charity.

Superintendent's Report: Mr. Ron Cowell, from The Education Policy & Leadership Center (EPLC) provided a presentation on Education Funding.

The Board approved the following items at their February 16, 2021 Board meeting:

- Approved Jason Gregor to transfer from a part-time to a full-time custodian to fill a vacant position.
- Approved the Allegheny Intermediate Unit (AIU3) Lease Agreements for two classrooms (Head Start and Pre-K) at Bellevue Elementary and a Lease Agreement for a classroom at the Northgate Middle/High School for a DART classroom.
- Approved the request of Avonworth Soccer to use the high school practice field from 6:00 to 7:30 p.m. April 6 - May 27, 2021 on the evenings of Tuesday, Wednesday and Thursdays. The facility fee will be a total of \$1,080.
- Adopted The Chill Project, offered through Allegheny Health Network, in all three buildings beginning with the 2021-2022 school year. Approximate annual cost of the program is \$200,000.
- Approved the updated Phased School Reopening Health and Safety Plan which details procedures for the opening of school.
- Approved the proposed revised Middle/High School Handbook.

- Approved the proposed 2021-2022 Allegheny Intermediate Unit Program of Services budget in the amount of \$2,161,057. The Allegheny County (AIU3) school districts' total contribution to the budget is \$1,811,545. The Northgate School District contribution to the Program of Services budget is estimated to be \$13,178 and will be determined by PDE according to District Aid Ratio and Weighted Average Daily membership (WADM).
